CALL TO ORDER Hugh Tyner, Chairman

1. WELCOME

Mr. Tyner welcomed everyone and thanked them for coming.

2. APPROVAL OF MINUTES – July 29, 2004

MOTION: Maurice Robbins made a motion to approve the Minutes of July 29, 2004. The motion received a second from Ken Cochran and passed by unanimous vote.

3. STATUS OF DRAFT LONG RANGE TRANSPORTATION PLAN

Mr. McHenry said the Long Range Transportation Plan they had received had been significantly reworked since the original plan. They have had discussions with the Federal Highway Administration, with Hall Area Transit, and with the Atlanta Regional Commission in terms of input and changes in that document. In terms of the public outreach they had a public meeting on August 31, 2004 and received a number of comments on the plan that have been incorporated. They will be having another public meeting on November 4, 2004 from 5:30pm to 7:30pm at the Georgia Mountain Center. He said they would also be putting the document out for the 45-day public comment period starting on October 18th to December 1st. The next CAC Meeting is scheduled for Thursday, December 2nd at 4 pm to review the final document before its anticipated adoption by the Policy Committee on December 14th.

4. RESOLUTION REGARDING MLK BOULEVARD DESIGNATION

Mr. McHenry pointed out there were three revisions to the State and Federal Highway System that have already been approved by the City of Gainesville and GDOT. With the MPO in place, changes need to have approval from MPO Policy Committee. The change is removing State Route 11 & US Route 129 Business designation on MLK Boulevard and placing this designation onto E.E. Butler and Jesse Jewel Parkway. Because of the existence of the newly formed GHMPO, the Policy Committee needs to approve these changes.

MOTION: Augie DeAugustinis made a motion to approve the Resolution Regarding MLK Boulevard Designation and forward to the Policy Committee. The motion received a second from Bryan Puckett and passed by unanimous vote.
