1. Welcome

Mr. Yamala called the meeting to order at 10:00 a.m.

2. Approval of October 19, 2011 Meeting Minutes

MOTION: Mr. Taylor made a motion to approve the October 19, 2011 Minutes with a second by Mr. Ligon and the motion passed by a unanimous vote.

3. Review Draft FY 2013 Unified Planning Work Program (UPWP)

Mr. Yamala presented the Draft FY2013 UPWP for review stating the overall funding summary is basically the same as last years. The FY 2013 local in-kind match salaries and direct costs are being revised and will be provided in the updated draft in April.

Mr. Yamala mentioned that he received a request from the City of Gainesville Mayor, Danny Dunagan and city staff to begin working with a consultant on a long-range transportation study for the City of Gainesville. He added that the study would focus on improving the flow of traffic through Gainesville and that only one Transportation Investment Act (TIA) project, the intersection at Jesse Jewel Parkway and John Morrow Parkway, is in Gainesville itself.

4. Update on the Transportation Investment Act (TIA): Public Outreach Efforts

Mr. Yamala repeated a presentation on the TIA which he has given to numerous groups and organizations countywide. He stressed the GHMPO can only educate and not advocate for or against the measure. Mr. Yamala laid out the basic facts: the long-term gas tax and Hall County's transportation needs will increase dramatically driven by projected rising population and employment figures.

Mr. Yamala informed the members that Todd Long, Director of Planning at GDOT, will speak at the Greater Hall Chambers Annual GDOT Transportation Forum on March 14, 2012, 11:30 AM to 1:00 PM at the Gainesville State College.

5. Jurisdiction and Agency Reports

Representatives discussed the status of transportation projects being completed by their jurisdictions: Mr. Taylor for the City of Gainesville, Mr. Brown for the City of Oakwood, Mr. Mahoney for GDOT and Mr. Woodall for Hall County.

The next TCC meeting is scheduled for April 18, 2012.
