1. Welcome

Ms. Scott, Vice Chair, opened the meeting at 10:30 AM.

2. Approval of July 10, 2019 Meeting Minutes

MOTION: Mr. Yamala made a motion to approve the minutes of the July 10, 2019 meeting, with a second from Ms. Brady, and the motion passed by a unanimous vote.

3. Recommend Approval of the Resolution Adopting the Jackson County Transportation Plan

Mr. Cote presented the transportation plan Jackson County has recently completed. This plan assessed Jackson County's existing transportation network and recommended a list of transportation projects for implementation over the next 30 years.

MOTION: Mr. White made a motion to recommend approval of the resolution adopting the Jackson County Transportation Plan, with a second from Mr. Tarver, and the motion passed by a unanimous vote.

4. Recommend Approval of the Draft Project List for Gainesville-Hall Regional Transportation Plan: 2020 Update

Mr. Cote presented a draft financially-constrained list of transportation projects that would be included in the next update of the Gainesville-Hall Regional Transportation Plan. The projects with federal funding were broken into four time bands: Band 1 (2020-2025), Band 2 (2026-2030), Band 3 (2031-2040), and Band 4 (2041-2050). There is an additional list of transportation projects with other (state and local) funding sources. Mr. Cote also shared a second draft project list which shows project R-9/PI 013545/GH-109 (I-85 Widening from SR 53 to SR 11/US129) shifting into the "Other Funding" project list. This is a potential solution that GHMPO staff and GDOT Planning have been working through in order to free up additional funding for projects to move into Band 2 of the draft project list. Though this is not finalized, staff is expecting this project to be funded utilizing additional Major Mobility Investment Program (MMIP) funds.

MOTION: Mr. Yamala made a motion to recommend approval of the second Draft Project List presented for the Gainesville-Hall Regional Transportation Plan which shows project R-9 / PI 013545 / GH-109 funded by additional MMIP funds, with a second from Mr. Rotalsky, and the motion passed by a unanimous vote.

5. Jurisdiction and Agency Reports

Representatives shared the status of projects being completed by their jurisdictions: Mr. Andrew for the City of Flowery Branch, Mr. Tarver for the City of Gainesville, Mr. White for the City of Oakwood, Ms. Scott for the Town of Braselton, Mr. Kirby for Georgia Department of Transportation, Ms. Lewis Moss for Hall Area Transit, and Mr. McInturff for Hall County.
