1. Welcome

Chairman Higgins opened the meeting at 10:00 AM.

2. Approval of March 9, 2021 Meeting Minutes

<u>MOTION</u>: Mayor Dunagan made a motion to approve the draft meeting minutes of the March 9, 2021 Policy Committee meeting, with a second from Ms. Roy, and the motion passed unanimously.

3. Approval of Draft FY 2022 Unified Planning Work Program

Mr. Boyd gave a brief overview of the final draft of the FY 2022 Unified Planning Work Program. The primary change in this draft was the inclusion of the Braselton Trail Study, which is expected to be completed during the second quarter of FY 2022, as well as the inclusion of the Sidewalk Gap and Inventory Study, which was proposed by the Citizens Advisory Committee and has been added to the list of potential future studies.

MOTION: Mayor Dunagan made a motion to approve the Draft FY 2022 UPWP, with a second by Mayor Scroggs, and the motion passed by unanimous vote.

4. Other

Mr. Boyd provided brief updates from the Technical Coordinating Committee subcommittees regarding McEver Road and the Highlands to Islands Trail. The McEver Road Subcommittee is continuing to evaluate options for alleviating congestion along the McEver Road corridor south of Mundy Mill Road, while the Trails Subcommittee is continuing to finalize and prioritize future trail routes for the Highlands to Islands Trail.

Additionally, the GHMPO, alongside the Town of Braselton, has officially contracted Alta Planning + Design to conduct the Braselton Trail Study, assessing the feasibility of connecting the current endpoint of the Life Path near the intersection of Friendship Road and State Route 211 to Downtown Braselton.

5. Jurisdiction and Agency Reports

Representatives shared the status of transportation projects in their jurisdictions: Mr. Andrew for the City of Flowery Branch, Mr. Tarver for the City of Gainesville, Mr. White for the City of Oakwood, Mr. Mullins for the Georgia Department of Transportation, Ms. Moss for Hall Area Transit, Mr. Yamala for Hall County, and Ms. Roy for Jackson County.

Ms. Moss announced that Hall Area Transit would be holding public hearings in June regarding proposed changes to their transit service. These changes include the elimination of the Dial-A-Ride service as well as the Gainesville Connection fixed routes by June 30, 2021. On July 1, all services would then be rolled into the newly launched WeGo microtransit service, which will serve all of Hall County. The in-person public hearings are scheduled for June 2 at 10:30 AM, 11:30 AM, and 12:30 PM. Additionally, virtual public hearings will be held on June 3 at 12:00 PM, 1:30 PM, and 7:00 PM.
